Select Ignatius titles are available under all ProQuest’s lending/purchase models:

-Subscription collections

-Single User

-3 Users model (concurrent access limited to 3 users)

-Multiple users (no limit on concurrent users)

-Non-Linear Lending (a title can be borrowed up to 200 days/year)

-Short Term Loan/Access to Own (“Access to Own” (ATO) is an ebook purchase model for institutions that wish to license a Title for a designated loan period in exchange for a fee represented as a percentage of the Publisher’s List Price. Once an institution’s accumulated ATO loans on a particular Title exceeds the Publisher’s List Price, the institution will then have purchased a perpetual license to the book. The triggered purchase will be in the form of a single-user license (SUPO) unless the title is also available under other perpetual license models such as multi-user license (MUPO) or non-linear-lending (NLL), provided that the appropriate additional fees are paid. In addition, the ATO models supports an up-sell option under which an

institution may elect to purchase a Title for which they have one or more ATO or STL instances by paying the difference between ATO or STL fees accumulated to date and the current Publisher's List Price of the Title.

### **EdTech Software, LLC (shelfit.com) – Platform designed for Educational usage**

Educational account purchases or rents digital titles and they appear on the Students' Bookshelf automatically. Provides additional teaching overlays within each digital book. Extensive collection of past Ignatius Press ebook titles for purchase with special catechetical series available for rental periods. Membership account is required.
